## Title transfer cost

You must also transfer the car title if you are giving the car as a gift or a donation to a charity. When transferring a car title, both the seller and the buyer, are required to sign the title. The car title serves as a legal proof of property and is used by the new owner to get the registration in the name of him. Flip the title of your car at the back to look for the signature lines. The signatures typically do not go on the front of the title. If you have an older title, you might only have signature lines on the front. Fill out the other required areas of the title before signing. The date, reading of the odometer, the sale price and the names and addresses of the buyer and the seller must be completed before the title is signed for the transfer. Sign the line for the seller if you are the person who transfers the car title. If you receive the machine, make sure all other information is correct, which sign on the line for the buyer. There are procedures you need to follow when moving the title of your bike to a new owner. Provide all the necessary documents as requested by the laws of your state.
